Develop and deliver our programme of Building Safety compliance ensuring that we remain fully compliant with all statutory, regulatory, and best practice building safety requirements.

Provide assurance to our Board of Management through comprehensive performance reporting that we remain fully compliant with all statutory, regulatory, and best practice building safety requirements.

Complete and submit all relevant Regulatory Building Safety Returns the Regulator of Social Housing

To ensure complete and accurate Property Digital Records are maintained for all relevant buildings.

Develop and maintain Building Safety Cases for all buildings in Scope of the Building Safety Regulator and be responsible for applying for Building Assessment Certificates.

To be responsible for the delivery of the Fire Safety Regulations 2022.

To deliver landlord compliance and sustain sector leading performance for Fire Security and Life Safety Systems, Asbestos, Water Hygiene, and LOLERs.

To act as the deputy organisational lead for our Primary Authority Partnership with West Midlands Fire & Rescue Service (WMF&RS). To introduce new ways of working that will improve the service to tenants and improve business efficiency, with a key focus on maximising front line productivity, cost control and the overall tenant experience.

Define and implement contract management processes, including the development of contractor KPI's, ensuring service review meetings are conducted regularly with all contractors.

Develop and maintain robust procurement plans to support the effective management of an active contractor supply chain.

Ensure the effective procurement, monitoring and delivery of our building materials supply chain.

Maintain the effective management and control of all procurement and commercial activities, ensuring tight performance of KPIs and budgets are met.

Support the Director of Building Safety to plan future spend requirements, formulate, and monitor budgets and deliver value for money for tenants and the organisation.

Work closely with internal and external auditors, validating data requests and responding in a timely fashion. Review and make recommendations on audit next steps, ensuring owners are assigned and plans are put into place to address findings.
